The bond will be used to meet such costs, plus any fines that might be imposed by the Municipal Council arising from breaches of planning relating to the hire.
9. That the hirer will not use the Hall for any purpose other than that detailed at 2 above.
10. That the hirer, if a company, is responsible for holding public liability insurance to cover loss or damage suffered by persons involved in activities carried out at the Hall by the hirer.
11. That the Strathewen Public Hall Association Inc is not responsible for any loss or damage to the property, or to the person, of any person using the Hall as a result of this Hire Agreement, and that the hirer will not hold the Strathewen Public Hall Association Inc nor its agents liable for any personal injury or loss of property caused howsoever, including negligence of the Strathewen Public Hall Association Inc.
12. **Code Red Days & Extreme Fire Danger Days** – The Committee reserve the right to cancel a booking should a Code Red Fire Danger or Extreme Fire Danger day be called in relation to a day for which a booking has been made.

The hirer would be contacted as soon as a Code Red Day was declared and any monies paid would be refunded in full.

The hirer would be contacted as soon as an Extreme Fire Danger Day was declared and the Committee has considered the event an unacceptable risk and any monies paid would be refunded in full.
